

Prisoner Health

- **Psychotic Disorder**: 10% of male remand prisoners (0.4% in general population)
- **Neurotic Disorder**: 76% of female remand prisoners
- Alcohol: 1/3 of women and almost 2/3 of men entering prison have an alcohol problem
- **Drugs**: Two-thirds (69 %) of prisoners have used at least one drug during the year
- **Smoking**: 80%. I kid you not
- Self Harm: 35% considered suicide in the past year, 27% of male remand prisoners said they had attempted suicide at some time
- **PTSD**: 9% of female remand prisoners met criteria
- **Personality Disorder**: 78% found in male remand prisoners
- Learning Disability: 20 to 30% (Prison Reform Trust, 2007)
- **Physical Complaint**: One third of men; four fifths of women mostly musculoskeletal and respiratory

Hep C in prisons

- 100,000 people in England with Hep C
- 90% have injected drugs
- 2/3 will pass through prison
- Great place to find, support and treat






Benefits of Peer to Peer



Role of the Peer

Gain an understanding of the issues that affect those with hepatitis C	Promote the Peer Education workshops	Delivery of life story in the format of the Peer Education workshops	Provide accurate, up to date information about hepatitis C	Delivery of peer 2 peer talk
Provide advocacy and referral to The Hepatitis C Trust	Promote self-help awareness of hepatitis C	Encourage uptake of hepatitis C services	Collect feedback after each Peer workshop and return to the Prison Peer Educator.	Support the Peer Educator during wing surgeries; Hep C awareness raising, BBV testing day

- ► High Intensive Test & Treat
- Test the full population of the prison over a short period of time
- Educate prisoners & staff
- working in partnership with ODN, Prison, Drug & alcohol services
- Look to gain micro-elimination
- Funded by NHSE
- Incentives for prisoners to take Hep C test

Data Doncaster HITT

- 98% of the prison population tested
- Tested 1085 residents
- 21 new PCR positives
- 21 new diagnosed
- 21 all started treatment within 14 days

Peer Data FOR Yorkshire Prisons April 2021 to present day

252 staff trained in hep c
413 Residents trained in hep C
4927 residents have been contacted through out reach
